

Contesting Liminal Spaces: A Study on Select Women's Narratives from Tibet and Bhutan

Rashmi S. Pillai

Abstract

This chapter discusses how characters in select women's narratives from Tibet and Bhutan contest the rites of passage and liminal spaces in their lives. The gender, social, geographical, cultural, religious spaces and other aspects attributed to myths and folklore are contested by these women characters in the narratives – which include a memoir, a travelogue and two novels – in similar as well as different contexts, but almost similar geographical landscapes; along with the social, cultural and national rites of passage that can cause a liminal fluidity. At the same time, it can also be observed that these women put up a strong resistance to the external efforts which forcibly alter their identity, but their eros overcomes this resistance. They try to unify with their previous state of unity or unify in ways in which their previous state of integrity would not have permitted.
