ORDER

The workload of teaching staff in Government and Aided Arts & Science colleges in the State were revised as per the Government Orders read above. In the above Government Orders it was stipulated that the date of effect of modified criteria for fixation of workload will come into force with effect from 9/05/2018.

- 2. Since various teaching organisations have raised concern over the issuance of the above Government orders, the matter has been re-examined by Government and are pleased to modify the Government Orders read as 2nd and 3rd papers above to the following extent.
 - i) The Government Orders $\,$ read as 2^{nd} and 3^{rd} papers above, shall be with effect from 1/6/2020 only.
 - ii) All selections and appointments made from 1/6/2020 onwards in Government and Aided Arts and Science colleges, shall follow the conditions stipulated in Government Order read as 2^{nd} paper above.
 - iii) The approvals pending, on the appointments made between 9/5/2018 and 31/5/2020 by a valid Selection Committee which should have been constituted as per the existing Government Orders, shall be considered in the light of the Government Order read as 1^{st} paper above.
 - iv) All other conditions in the Government Orders read above will remain

ORDER

The Manager, Malankara Syrian Catholic Colleges, Thiruvananthapuram vide paper read as (1) above, forwarded the proposal for the approval of the initial appointment of Dr.Alexander T as Assistant Professor in Environmental Science, St. John's College, Anchal, w.e.f 18.11.2019 against the vacancy of Dr.Jude Immanuel, Assistant Professor who relieved from service on 27.12.2017.

Meanwhile Dr.Reshmi RR, second rank holder, filed a writ petition before the Hon'ble High Court of Kerala challenging the appointment of Dr.Alexander T and the court vide the Interim Order read as paper (3) above directed to refrain from approving the appointment of Dr.Alexander T as Assistant Professor in Environmental Science, at Malankara Syrian Catholic Colleges, for a period of one month and the period was further extended.

The Honourable High Court of Kerala vide its Judgement read as paper (4) above, ordered to set aside the selection of Dr.Alexander T as Assistant Professor in Environmental Science, St.John's College,

The Division Bench of the Honourable High Court of Kerala vide Judgement read as paper (8) above, ordered to set aside the impugned judgment by dismissing the writ appeal read as (5) above and allowing the writ appeals read as (6)& (7) above.

In compliance with the Judgment dated 25.08.2022 of Hon'ble High Court of Kerala, the Educational Agency, vide paper read as (9) above, requested to reconsider the proposal for the Initial Appointment of Dr.Alexander.T as Assistant Professor in the Department of Environmental Science at St.John's College, Anchal, w.e.f 18.11.2019.

The Standing Committee of the Syndicate on Teaching and Non-Teaching Staff of Private Colleges held on 07.10.2022, vide paper read as (10) above, considered the above proposal, along with the judgment of the Hon'ble High Court of Kerala dated 25.08.2022 in WA 236/2021, WA 271/2021 & WA 491/2021 against the Judgment dated 18.12.2020 in WP(C) No.15666/2020, recommended to approve the same. The Syndicate, vide paper read as (11) above resolved to approve the proposal.

Sanction has therefore been accorded by the Vice-Chancellor for the approval of the initial appointment of Dr.Alexander T., as Assistant Professor in the Department of Environmental Science, St.John's College, Anchal, w.e.f 18.11.2019 against the relieving vacancy of Dr.Jude Immanuel, Assistant Professor, subject to the provisions contained in Kerala University Act, Statutes, Regulations and

APPOINTMENT ORDER

Read: Judgment in WP© No. 28742/2020 dt. 06.10.2021 of the Hon. HighCourt of Kerala

As per the Govt. letter No. D2/484/2019 H Edn. Dt. 06.01.2020, concurrence for selection and appointment of 5 Asst. Professors in Mathematics was sanctioned together with other 6 posts of Asst. Professors in different Subjects ie 3posts in Mar Ivanios College (Autonomous) Trivandrum and 2 posts in St. John's College, Anchal under this Management. All the posts were retirement /transfer vacancies. Accordingly notification for selection was published in 4 National dalies and applications were invited for the above 5 posts also. The Interview was conducted on 23.10.2020 for the selection of Asst. Professor in Mathematics by a duly constituted Selection Committee and rank list was prepared and published on 23.10.2020which has the validity up to 22.10.2021. In the meantime Govt. issued an order No. GO(MS) 155/2020dt. 01.04.2020 withdrawing the PG weightage from the total work load with retrospective effect from 09.05.2018 and cut down the vacancy of Asst. Professor in Maths from 5 to 3 vide DCE'S letter No. D4/35264/2019/DCE dt. 08.10.2020 over ruling the earlier sanction of 5 posts. As suggested by the DCE, Trivandrum, the Management has appointed 3 Candidates from the rank list.

Now Dr. LIMNARAJ B.P, the Candidate included in rank list in position 6 approached the Hon. High Court of Kerala vide WP© No. 28742/2020 and obtained Judgment on 06.10.2021 that her case may also be considered as ordered earlier by the Hon. High Court in WP© No. 13456/2020 and connected cases thereon delivered on15.10.2020. The Judgment in 13456/20 has given directions to the 6th respondent (Manager) to reconsider the appointment by the petitioners in whatever subject or respective streams they had selected and consider the same in the light of Govt. order No. GO(MS) 313/2020 H Edn dt. 11.09.2020. As the validity of rank list will expire on 22.10.2021, Dr. LIMNARAJ B.P, B.P.Nivas, Mekkunıkara, Keezhkolla, Vattavila, P.O, Pin - 695132 (open category rank 6) is appointed as Assistant Professor of Mathematics under this Management on a rationalized entry pay starting from

Rs.57,700 to Rs. 1,62000 (Academic level 10) per month and is posted as such in the St. John's College, Anchal from the FN of 20.10.2021 vice Sri. P.A Benedict, Associate Professor of Mathematics retired from Service on 31.05.2017. Subject to the provisions of the Kerala University Act 1974 and the Statutes, Ordinance and Regulations made there under and such other rules and orders issued from time to time by the University of Kerala, or by such other authority who may be competent to issue such rules, orders, etc. under the said statutes.
