
Item 2.3 Institutional quality analysis.

UGC sponsored Add on Course in "IT Enabled English Language Skill Development"

Minutes of the meeting

October 11, 2018: The department of English conducted a meeting at 1 pm in the staffroom to discuss the effective running of the UGC sponsored Add on Course in "TT Enabled English Language Skill Development." This was as per the decision taken by the College Council on October 5,2018. The members who attended the meeting decided to select a co-ordinator for the course. Ms Rashmi S Pillai, Assistant Professor of English was selected as the coordinator of the programme. Applications would be open to the first-year students of all departments. There would be an intake of twenty to twenty-five students with sufficient focus on SC/ST intake. The outline of the syllabus which had already been framed would be divided into four modules which would focus on IT, LSRW and soft skills. An orientation would be taken for the selected students from the list of applicants in the coming days. The first batch would commence from November 2018. Faculty members of the department would take classes for the students after college (3:30 – 4: 30 pm) and on Saturdays. The remuneration for one hour would be Rs 750/-. Report

The department of English had applied for an Add on Certificate or a Diploma Course to the UGC in 2014. The UGC sanctioned a financial assistance of Rupees 7,00,000 /- (Seven Lakh only) and released a grant of Rupees 6,30,000/- for conducting a Certificate Course in "IT Enabled English Language Skill Development."

Sufficient equipment has been procured for the smooth conduct of the course. The first class of the course with Batch I commenced on December 5, 2018. So far, three batches have been enrolled into the add on course.

Relevance of the course

The advent of IT revolution has opened new avenues for the English language student. In the current scenario, technology is an inevitable element of language education. The acquisition of English language with the aid of resources from technology enables a student to keep abreast of the latest developments in the job market. As our college is situated in a rural area, the students here do not get the opportunities available to the urban student. This puts them at a disadvantage when it comes to finding a career where they have to compete with the urban student with better language skills and computer skills. Our graduates require training in basic language skills, technology and soft skills. This is a need to be addressed. Keeping this in mind we have designed a course which will give the student an opportunity to seek jobs in multi-national companies and call centres.

Objectives

The course aims at enabling the students to meet the growing demands of the IT industry by giving them an equal platform to compete with the urban student. A boost in their English language skills will give them the confidence to pursue their dreams of a better career.

Outline of the Syllabus

The contents are designed to impart an integrated understanding to the learners about the English language with the aid of modern technology.

Basics of computer

- IT enabled grammar acquisition
- Development of listening and speaking skills with audio visual aids
- · Development of reading and writing skills
- Soft skills training

Pedagogy

The pedagogy includes interactive lectures where the student is given an opportunity to apply their language, IT supported presentations and seminars, on-line browsing, field visits, dissertations, assignments, examinations and project works.

Target Group

- Pursuing a career in call centres, MNCs, Advertising agencies, Flight crew, Media,
 Management sectors, Teaching
- · Improving their communication skills
- · Developing their soft skills

Expected Outcome

The course will create a confident young group adept in English language. Apart from pursuing a career related to this field they can also act as members of advisory bodies in educational institutions and can render their service in moulding a generation of students who are skilled in soft skills. Moreover, they will be competent in facing interviews and giving training for those who are preparing to face interviews. Their technological skills will give them an edge over others in fields requiring technical expertise and language skills.
